The Latvia Residency by
Investment program is one of the
most straightforward and
affordable ways to obtain longterm European Union residency for
you and your family.

Latvia offers golden visa (residence) to foreign investors who invest in the Latvian economy. Family members also qualify for temporary residence permits in Latvia.

Latvia has been a member of the European Union since 2004 and adopted EURO in 2014, actively participating and benefiting from EU funding, single market access, and security cooperation.



Latvia is a baltic country, EU member state and a member of Schengen area. Latvia has one of the earliest countries that established GV program in Europe. The Latvian golden visa scheme officially known as "Latvia Investor Immigration Program" was launched in July 1, 2010 amending the Immigration Act, to offset 2008 economic crisis.

The Goal behind this scheme was to attract foreign investors in order to facilitate Latvia's economic recovery and growth by activating the real estate market and creating new jobs.

Unlike in countries such as Germany or Portugal, Latvian residency holders do not lose their status if they spend less than six months per year in the country. Many families use this opportunity to secure EU residency and mobility now, and decide later whether to relocate or not.





Latvia has defined investment routes under the Golden visa program.
Applicants are screened by the competent authorities. More serious concerns about an individual's background are handled by the security police.

The PMLP migration directorate is the <u>only State authority competent</u> to decide on granting residence permits and visas. Latvian diplomatic and consular missions in other countries support the PMLP

The Law requires <u>prior checks for clean criminal record/background checks</u> as a criterion for granting a residence permit to investors. The Security Police checks the background of all foreign investors. If the Security Police have concerns about the origins of money, they ask the Latvian FIU to investigate the matter.

### RESIDENCE PERMIT

The Initial Residence permit shall be issued for 5 years and can be renewed upon same conditions. It can be used to freely circulate in the schengen area for upto 90 days in schengen states.



## FAMILY MEMBERS

Residency covers the investor, spouse, and children under 18 years old, each receiving biometric ID cards allowing free Schengen travel.

# Families have no physical stay requirement.

If you and your family are considering relocation or long-term mobility in the European Union, please note that Latvia is one of the few countries where you can keep your EU residency without a physical stay requirement. It is an ideal solution for families seeking freedom of movement, a secure backup plan, and future relocation flexibility — all within a reasonable investment level.

- Processing time: approx. 3-4 months (depending on nationality)
- Result: Instant 5-year EU Residency with biometric ID cards
- After permanent residency is granted, shares may be transferred to a third party if desired.

the immovable property represents a vacant land) with buildings in the and the total value of the real estate is at least EUR 250 000, or outside the said administrative territories – no more than two immovable properties (with exception of the cases when the immovable property represents a vacant land) and each of them represents one functionally connected immovable property, total value whereof is at least EUR 250 000 if the following conditions exist concurrently:

#### **Conditions**

- You have no real estate tax debts,
- The payment of the total real estate value has been made by non-cash settlement,
- Real estate has been purchased from a legal entity registered in the Republic of Latvia or a Member State of the European Union, any country of the European Economic Area or the Swiss Confederation and which is a taxpayer in the Republic of Latvia within the meaning of the tax laws of the Republic of Latvia; or the real estate has been purchased from a natural entity who is a citizen of the Republic of Latvia, a non-citizen of the Republic of Latvia, a citizen of the European Union or a foreigner who is staying in the Republic of Latvia on the basis of a valid residence permit.

# Residential Property with Title Deed



After Receiving Temporary Residence Permit, Applicant must pay 5 % of the real estate purchase value into the state budget.

- The total cadastral value of the real estate is at least EUR 80 000 at the moment of purchase. If a foreigner has acquired two immovable properties outside Riga or Jurmala, or in Adazi, Babite, Baldone, Carnikava, Garkalne, Ikskile, Kekava, Marupe, Olaine, Ropazi, Salaspils or Stopini municipalities, cadastral value of each immovable property at the time of acquisition thereof shall be at least EUR 40 000. If the cadastral value is below the amounts referred to in this sub-clause, the total value of the real estate in accordance with the real estate market value determined by a certified real estate appraisal shall not be below EUR 250 000 or, if a foreigner has acquired two immovable properties – market value of each immovable property may not be less than EUR 125 000;
- Upon applying for a first temporary residence permit, the person must pay 5% of the real estate purchase value into the state budget;
- The real estate must not comprise agricultural land or wooded land







- **Deposit term:** The deposit must be fixed for at least five years.
- State budget fee: A one-time fee of €25,000 is required when the permit is granted.


Opening a bank account is required. All Latvian banks are fully compliant with EU banking system and share the similar experience as of the other European banks.

## RESIDENCY BONDS



- **Deposit term:** The deposit must be fixed for at least five years.
- **State fee:** A one-time fee of €38,000 is required when the permit is granted.



# Interest-free government bonds

Acquisition of interest-free government bonds shall be done after a positive decision has been made on granting a temporary residence permit







### LATVIA PERMANENT RESIDENCE

- **Residence:** After 5 years of holding temporary residence permit.
- Language Test: knowledge of the Latvian language in the A2 level.

### LATVIA CITIZENSHIP

 has been permanently residing in Latvia for not less than the last 5 years (a citizen of another country has a permanent residence permit in Latvia for a period of 5 years)



# **5 YEARS**

If a foreigner has lived in Latvia with an issued temporary residence permit for at least 5 years, then he or she shall be entitled to request a permanent residence permit.



### **10 YEARS**

- Prove it with documents; knows the text of the National Anthem, the basics of the history and culture of Latvia, and the bac principles of the Constitution of the Republic of Latvia;
- Fluent in Latvian;
- has a legal source of income.

#### 2. How to get Latvia permanent residency?

After 5 years of living and passing language test.

#### 3. Can i sell the company shares?

Yes, you can sell the shares to third parties to recover your share investment

#### 4. What is the processing time.?

Applications are processed quite fast by authorities within 90 working days.

### 5. What rental returns available with property in central Riga?

About 4% rental income possible.

### 6. Do you help with opening bank account in Latvia?

Yes, we can for additional fee.

#### 7. Are there any minimal residency?

None.

#### 8. Does Latvia permit dual citizenship?

Only with certain countries with agreements,

#### 9. Do i have to personally visit Lativa?

Yes, once for biometrics at migration office.

### 11. What documents are required?

Documents to be submitted for Latvia Immigration through Share Capital Investment

- Application form of residence permit.
- Photograph (to be attached with application form).
- Necessary subsistence Proof (as of 1 April 2015).
- Proof of planned accommodation in Latvia.
- Document confirming state duty payment.

Before submitting these documents, you inviter or sponsor (Latvia citizen) need to approve the invitation letter at the Office of Citizenship and Migration Affairs in the Republic of Latvia.


### 15. What type of residence permit granted for Golden investments?


TRP (Temporary residence permit valid for 5 years). You must meet additional conditions for PR and citizenship including passing latvian language test.
